2011 Annual Report

In 2011, the Lake Champlain watershed experienced catastrophic hydrologic events that amounted to widespread devastating environmental and economic impacts. Spring floods and lake shore erosion, along with massive upland stream erosion caused by Tropical Storms Irene and Lee, resulted in a high number of distressed areas in critical need of substantial remediation. CWICNY continues to work cooperatively with local partners, municipalities and landowners to repair damage, strengthen infrastructure and improve water quality throughout the watershed.

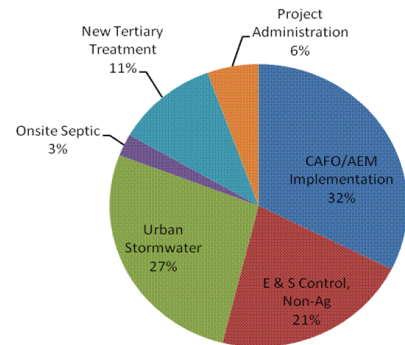
In 2011, CWICNY saw the culmination of projects funded by 2 major grants totaling over \$1 million! The grants, awarded to CWICNY and its member organizations, were for water quality improvement project implementation and planning throughout the watershed.

Targeted Watershed Grant

In 2008, CWICNY was fortunate to have received 1 of 12 nationally-recognized grants through the Environmental Protection Agency's Targeted Watershed program. This program designated \$900,000 in federal funds, and leveraged over \$1 million in local match, to implement a variety of projects throughout the five counties in the Champlain Watershed, reducing phosphorus inputs into Lake Champlain and its tributaries from priority sites throughout the watershed.

In total, five categories of non-point source pollution were addressed, including urban stormwater, agriculture, on-site septic issues, innovative wastewater/tertiary treatment systems and erosion and sediment control.

Roadside Erosion Assessment and Inventory

In 2009 the Lake Champlain - Lake George Regional Planning Board, partnered with CWICNY and its members, received a Federal American Recovery and Reinvestment Act grant to perform roadside erosion assessment planning throughout the Champlain Basin. Field work for the grant was performed by the five County Soil and Water Conservation Districts and CWICNY staff over two field seasons in 2010 and 2011. An array of information was collected and used to prioritize the sites as high, moderate or low priority for remediation efforts. An assessment matrix was produced for each site identifying the location, jurisdiction, sub-watershed, erosive parameters, management recommendations and costs. All together, 319 roadside erosion sites were identified in the five counties on local, county and state roads with a total remediation cost of \$1.7 million. The goal of producing this document is to leverage funding to remediate the sites using techniques such as hydroseeding, re-grading slopes, installing woody vegetation and utilizing rolled erosion and sediment control products.

Lake Champlain Watershed federally designated "America's Great Outdoors!"

Lake Champlain is one of three large watersheds in the Country specially recognized by President Obama as a landscape of national significance. This recognition lead to the designation of the Champlain Watershed as part of the Federal Governments "America's Great Outdoors" initiative. CWICNY, in partnership with Natural Resource Conservation Service (NRCS) and the NY Department of Environmental Conservation (DEC), is promoting this one-year initiative, offering a variety of educational workshops and programs throughout the watershed. Topics are focused on agricultural practices and non-point source pollutant issues facing the lake, including livestock grazing and exclusion for waterways, cover cropping, tile drainage, agricultural plastic recycling and shoreline buffers and stabilization. The 7th annual North Country Regional Stormwater Tradeshow was held at the Queensbury Hotel in Glens Falls, NY. The October 20th conference drew over 125 participants from Albany to Plattsburgh, as well as exhibitors from throughout the northeast showcasing new and innovative stormwater and erosion & sediment control products and services. Jim Tierney, NYS DEC's Division of Water Assistant Commissioner, was the featured guest providing the conference opening remarks, and speakers included John Dunkle, PE/CPESC of Dunn & Sgromo Engineers presenting *Green Infrastructure and Low Impact Development*; Andy Sansone, CPSWQ of Monroe County Environmental Services presenting *Detection and Elimination of Illicit Discharges to Storm Sewers*; and Scott Perry, CPSWQ of Imbrium Systems presenting *Phosphorus Treatment, Advanced Mechanisms and Design*. New to the program in 2011 was a local stormwater panel to discuss regulatory updates and local issues focused on the new DEC Design Manual, Chapter 5, Green Infrastructure. Panel members included Carol Lamb-Lafay of the NYS DEC; Suzanna Randall of EFC; and Tom Baird from Barton and Loguidice.
